MINUTES

Monday, October 14, 2024 Miss Saigon, N. State St, Ukiah, CA 95482

- 1. **CALL TO ORDER** President Tom Ingram called meeting to order at noon.
- 2. **Board Members: Present**: All board members. Guests are Brian Miller and Gayleen Deroches.
- 3. **APPROVAL OF MINUTES**: Dorinda Miller moves to accept the August 12, 2024 General Membership Meeting Minutes. Donna Glass seconded. **PASSED**.
- 4. **REPORTS**:
