SCHOLARSHIP INFORMATION FOR 2025/26

Deadline for Scholarship Application is May 30, 2025

Always check our website. Two new Scholarships will be awarded for the 2025/2026 year. All the rules and the application are located on our website. If you are a member of AMCRE, and have children or grandchildren going to college, university or trade school, they will be able to submit an application for one of the two \$1,000 scholarships we are giving out for the 2025/2026 school year. They can receive \$500 each semester with proof of full-time enrollment into a college, university or trade school and applying and submitting, per the directions in the application. A student who is returning to college, university or trade school for additional years and for graduating seniors who are going to enter college, university or trade school may also apply. Be sure all required letters of recommendations, transcripts, schedule of classes, and proof of enrollment are included in the application.

Go online and print out the application and read and follow all instructions. One original and two copies of everything are required. The student applying for a Scholarship should read all instructions in the SCHOLARSHIP TAB of our website AMCRE.org. Scholarship recipients, who previously won an award, may apply again.

If your child, grandchild or you won a previous Scholarship from AMCRE, be sure they read and understand the deadlines for submitting paperwork for their Award reimbursement.

Effective January 1, 2025, the deadline to receive the award money for fall semester must be submitted with required documents no later than October 31 each year. The deadline to receive the award money for spring semester must be submitted with required documents no later than June 1st each year. If there is a problem for the recipient to turn in the required paperwork by these dates, they must notify in writing to the Scholarship Chair to seek approval of an extension of time. Should the scholarship recipient fail to turn in the required paperwork by these deadlines, they forfeited their Scholarship award for that semester.

MCERA Updates:

Historical Benefit Review Project Update

I am pleased to report that the IRS agreed to the corrective actions outlined in MCERA's 2022 Voluntary Compliance Program (VCP) application and issued a compliance statement. Receipt of the compliance statement permits MCERA to retain its tax favored status under the Internal Revenue Code. At the October 16th meeting, MCERA's Board adopted a Resolution formally bringing a successful completion to the Historical Benefit Review Project, other than the need to complete the remaining corrections.

I would like to thank and recognize the County of Mendocino Board of Supervisors for the actions it took to assist in this Project. In 2021 and 2022, the Board of Supervisors adopted Resolutions 2021-196 and 2022-148 authorizing optional provisions in the County Employees Retirement Law to be operative in Mendocino County to facilitate MCERA's VCP application. This action permitted corrections that minimized the adverse impact to affected MCERA members.

As January 1st, there are only 52 account requiring recalculation. More information on the Project is available on our website through this link Historical Benefit Review Project and project updates are included in the Retirement Board meeting materials.

MCERA Popular Annual **Financial** Report **Comprehensive Annual Financial Report**

MCERA is pleased to announce the Popular Annual Financial Report (PAFR) and the Annual Comprehensive Financial Report (ACFR) for Fiscal Year 2024, from July 1, 2023 through June 30, 2024, are available on MCERA Annual Financial Reports webpage. The PAFR provides a short summary of MCERA's financial details and highlights from the more detailed ACFR.

We at MCERA believe in being transparent and open with our members, and the ACFR and PAFR are examples of that. MCERA received GFOA awards for financial report for both its PAFR and ACFR. The Government Finance Officers Association (GFOA) requires that both reports be readily accessible to any interested party.
